  - Keeping \$500 in Reserve

- To order more books in the future
- Currently holding about \$800 worth of books
- Tim from Salem area meetings has requested access to Intergroup's 30% off Literature discount
  - When Intergroup began funding the bulk purchase of literature, we gained access to a 30% off purchasing discount
    - It was voted to continue charging members listing price, members save on shipping
    - This would allow Intergroup to continue buying bulk literature without continuous funding
    - Literature income comes from the 30% price difference
  - If we provide a discounted pricing option for Tim's ACA groups, we'll need to provide this to all Oregon ACA groups
  - Will not be offering a discount for Tim at this time
