 - 6-18 weekly attendance
 - On hand reserve still low, prudent reserve is \$260
 - Low sales of books
- Thursday Rainbow Travelers
 - 5-10 weekly attendance
 - Strong 7th tradition for size
 - Beginning to pay back initial meeting start expenses
 - Refining meeting script and narrowing the meeting focus
 - New members coming each week
 - Brought in attendees from Salem this month
- Saturday Awareness, Courage, Action
 - 15-20 weekly attendance
 - November rent is paid
 - Transitioning roles for Secretary and Treasurer to other people with separate service positions
 - Roles are still open

Retreat Committee

Committee leader returning Retreat funds to Intergroup

- ~\$2000 Balance
 - Will refund persons who paid for the upcoming Retreat in advance
- There is general interest in a Retreat in the future, but there is no one who has stepped forward to initiate planning
 - David will help with planning when other members volunteer to lead the preparations
 - Ask and offer the opportunity to start Retreat planning to the Oregon ACA community at meetings
- Initial Retreat funds were provided by Intergroup
 - We don't want to return this money to the Intergroup general fund
 - David will create a bank account to set aside this money when people initiate the planning process for the retreat again

Retreat Planning Considerations

- Washington starts planning their retreat to be held in the Spring and Fall

- Cheaper location costs for an event hosting in the Spring or Fall
 - What's an estimate for the venue costs?
- Hard to plan a retreat to occur in the Summer since there are many competing events in the season
- Begin planning in January for a Retreat occurring in November
- Potential Locations
 - Tacoma, WA
 - Corbett, OR
 - Columbia River Gorge
 - Kiwanis Club (Mt. Hood)
 - Twin Rocks
 - Managed by Quakers
 - The greater community is disapproving the LGBT+ community
 - Local people are welcoming, but the philosophy may deter LGBT+
 ACA members from attending
 - Scenic Location not necessary
 - Can request quotations from venues before committing to a location
- Around 50 75 attendees
 - Costs ~\$200 per person
 - Sponsorship available and included in overall pricing for the community
 - 50% of people request financial assistance
- What happens at a Retreat?
 - Workshops led by the community
 - Catering at venue included
 - Limited on-site lodging depending on venue
 - Shared rooming
 - Extra costs for separate rooms
 - Need space and planning included for workshops and free time
