ACA Retreat Survey

 - Accepted submissions from 3/17 5/9
- Updated Summary Document
 - 40 Submissions, 37 interested in retreat, 24 volunteers
 - Venue preference:
 - Columbia River Gorge (Hood River, OR): 28
 - Mt. Hood Kiwanis Camp (Government Camp, OR): 20
 - Twin Rocks (Rockaway Beach, OR): 27
 - Corbett, OR: 12
 - Tacoma, WA: 1
 - Other suggestions: Manuka Retreat Center, Makenzie River Area, Ocean Park, WA
- Will need to follow up with volunteers to create a Retreat Committee
 - Results of survey can be used as a reference as direction for future planning
 - Message those who offered contact information:
 - If you have put your contact info into the survey, we will reach out to you shortly
 - Ren will work on a draft and bring to next month's Intergroup meeting for approval

Discussion:

- History of ACA Oregon Retreats:
 - Washington's ACA community had been hosting two Retreats a year and needed assistance to continue hosting Retreats at their pace

- Oregon ACA was asked to hold one of the yearly Washington ACA Retreats at Pilgrim Firs in Tacoma, Washington
- This venue ended up being too expensive, so it was held at Twin Rocks, OR instead
- One of these retreats became ACA Oregon's Retreat, the other Washington ACA Retreat is now held in Seabeck, WA
- From 2016 2017, Oregon Retreat was held at Twin Rocks, OR
- From 2018 2019, Oregon Retreat was held at Mt. Hood
- Retreat has not been held since 2019 due to COVID-19 restrictions and change in fellowship members
- Retreat Funds were created by charging attendees an additional fee to go towards scholarships for other ACA members, and towards planning future ACA Retreats
- Why can't we combine the Retreats and Getaways?
 - Retreats and Getaways are different
 - Retreats are focused on workshops, classes, and active recovery
 - Are busy and require a lot of work to plan
 - Getaways are focused on fellowship and relaxation
 - Multiple people in the Retreat survey asked for the Retreats and Getaways to be combined
- Previous Retreat funds were given to Intergroup to manage by the previous Retreat Treasurer
 - Want to avoid making a decision on allocating funds for the Retreat until a Retreat committee is formed

ACA Getaway

- Getaway committee is requesting funding to reserve the venue for the April 2025 Getaway for \$1200
 - Venue at Ocean Park, WA now requires a 25% deposit to hold the date a year in advance
 - Ruth has already paid for the deposit and wants to be reimbursed
- How are current Getaways funded?
 - Attendees charged at cost (\$216 for a three night stay)
 - Want to make the price equitable for all members
 - What other funding avenues could be investigated?
 - June Speaker's Meeting Silent Auction
 - Charge more for Getaway
 - Requesting funding from Retreat funds that aren't being used
 - Pulling funding from the Retreat reserve could create even further barriers to hosting a retreat in the future
- Getaway attendance is currently capped at 25 people
 - Could be increased if there was enough interest
 - Will look into increasing the attendance cap
 - Almost didn't make the 20 minimum person attendance for April 2024
