## Treasury Report

### Intergroup Funds

- **\$1935.71 Reserve**
  - Income:
    - Breaking the Bonds book sales income: \$10 (not yet applied to Treasury total funds)
  - Mixie elected and acting as new treasurer
    - David has passed on above funds to Mixie manage
    - Mixie has been provided a Cashier's Check and organization's EIN number
    - Mixie will be tracking money in a spreadsheet that can be shared and reviewed in future meetings

### Retreat Funds

- **\$2724.24 Reserve**
  - No change from last month
  - Retreat Committee Treasurer not yet elected to pass along from Intergroup

### Literature Funds

- **\$1313.00 Reserve**
  - Processing a purchase for a \$1207.00 literature order
  - Total on hand after purchase will be: \$106

## Meeting Reports

- Monday - **True Selves**
  - 15 - 25 attendees a week
  - Rent is paid
  - Planned meeting topic schedule still working well
  - Need to update the meeting type on AdultChildren.org from a “Beginners” meeting
    - Getting a lot of newcomers to this meeting specifically
- Tuesday - **ACA for Alcoholics**
  - 8-15 attendees
  - A growing and steady new meeting
  - Yellow Step groups forming from meeting
  - Working to get organized with Treasury and service
- Wednesday - **Gentleness, Humor, Love, and Respect**
  - 10 - 14 attendees a week
  - Rent is paid
  - Service positions still open
  - Many of the recurring attendees are newcomers
- Wednesday - **Hurting to Healing**
  - 20 - 25 attendees a week
  - Service positions are filled
  - Rent is paid
  - No major changes from last month’s report
- Thursday - **Rainbow Travelers**
  - 15 - 20 attendees a week
  - Service positions are filled
  - Continuing to craft “GayCA” meeting coins
  - Study workgroups forming from meeting
  - Decided to donate \$100, 50/50 to Intergroup and WSO
  - Setting aside \$100 for sliding scale funds for literature purchases
- Thursday - **Treehouse Meeting**
  - 11-12 attendees a week
  - Meeting is slowly growing
  - Made first literature sale
  - Working on building treasury funds
- Saturday - **Awareness, Courage, Action**
  - 40+ attendees a week
  - Filled meeting space, approaching pre-pandemic numbers
  - Most attendees are regular members
  - Not as many newcomers are present
  - Strong treasury
  - Working to encourage more service
- Saturday - **A New Hope**
  - Around 6 attendees
    - Most members are newcomers

- Guy and Lisa are members who have more time in the program
- Sunday - **A New Hope**
  - 10 - 12 attendees
    - 5 Attendees last week
  - Rent is paid
  - Going well, newer meeting
- Sunday - **Fellow Travelers**
  - 20 - 25 attendees a week
  - Strong treasury
  - No major changes from last month's report

## Old Business

- **Intergroup and WSO donations**
  - WSO announcement made March 1, 2023:
    - Suggested donation amounts now recommended as Intergroup: 50%, WSO: 50%
    - Says this information would be updated in BRB book printings
    - Will need to check if this has been applied yet to newer printings
  - Groups are autonomous and can decide within the meeting how they would like to apply their meeting donations
- **Intergroup Service Role Elections**
  - Recording Secretary: Shelley
    - Ren will follow up and be available for help with the role transfer
  - Vice-Chairperson: Not identified as necessary at this time
  - Literature: David
- **Intergroup Literature**
  - Current responsibilities of the Literature person:
    - Funds are separate from the Treasury, used to fund bulk purchases from WSO with 30% Intergroup discount
    - Store, maintain, and track book inventory
    - Distribute books to meetings when needed
  - Handles purchases with cash or check when needed. No Venmo account at this time
  - AA handles their literature sales and distribution to meetings differently
    - Literature persons make purchases and hand off literature at Intergroup meetings
    - Money is not handled by literature service members
    - Ren may need more clarification on the distinctions discussed in March Intergroup to provide more details
  - Katie wants to handle literature distribution for Intergroup at a central location
    - Does not want to pick up book orders at someone's house
    - Katie wants to handle literature duties
  - What central issues with how Literature is currently handled needs to be discussed?
  - Peter suggests we rent a space to hold books at the United Church of Christ in Lake Oswego for \$15/month
  - Intergroup meeting can also be held there for \$40/meeting from 1pm to 3pm on Sundays
    - Currently not paying rent for Intergroup meeting at the Alano Club
    - Changing location and timing of Intergroup meetings needs to be discussed separately
  - **Will table remaining discussion for April Intergroup Meeting**

## Events

  - Registration deadline: March 17th
  - Need 10 more people to register to hold the April Getaway
  - Ren will re-post the registration info to the website as a reminder
- **Retreat Committee Meeting**
  - Meeting weekly on Sundays
  - Working to decide on a site for the Retreat
  - Will open the meetings for all fellowship attendance when a consistent meeting time is scheduled
