#### **Secretary's Report – Approve/Correct**

1. Review Minutes 11/10//25
2. Changes:
  - a. Mixie's name is not spelled Mitzie
  - b. An addendum is referred to that doesn't exist
  - c. No mention of the webmaster role changing responsibility and being open for others to take on

#### **Treasurer's Reports – Approve/Correct**

1. Regular checking account as of 12/8/25 = \$779.85
  - a. Tommy brought up documenting the steps to becoming and maintaining the treasurer role

1. Monday - Action Coming from Love: Phoenix R., 15-17 people, service positions filled, not ready to donate, but doing well
2. Monday – True Selves: Absent
3. Monday - The Breathe Building: Absent
4. Tuesday – ACA for Alcoholics: Lisa, "Hi all, I have a conflict next Monday and will not be at Intergroup. I'll be giving up my Intergroup rep position in early 2026. It's been a pleasure. ACA 4

Alcoholics is doing great. 12-ish folks at the last few meetings. We are paying rent, have a small prudent reserve, but no money to donate beyond our expenses. We decided to get listed with ACA WSO. We are not currently. We are exploring what it means to be a group that overlaps 12 step programs. Which traditions we follow & who we affiliate with at the national/global levels.”

5. Wednesday- Gentleness, Humor, Love, and Respect: David (not official rep), service positions are unfilled for now (lots of changes, 13-15 people)
